### Subsequent questions to the Architect by Bidding Contractors in order received

### **Contractor Question 6:**

1. A4.01 key note 403 1.5" of Gypcrete, Is this to be installed throughout the entire upper floor? It's not specified in the finish schedule.

### Response Per Architect:

Yes, gypcrete throughout the upper level, with the following notable exceptions:

- the Mech. room 207 and the Janitor closet 208, which have sealed concrete floor finishes per Sheet A9.03 FINISH PLAN UPPER LEVEL.
- The new stair landings are to be new concrete with their top FFE set to the raised upper level FFE (inclusive of gypcrete), so the stair floors would not have the gypcrete top.
- 2. A4.10 Key note 850 referrers an in tub seat, but is pointed at the kitchen sink, please clarify.

### Response Per Architect:

Keynote referenced is mislabeled on the Typ. Kitchen Elevation, but correctly labelled on the enlarged plan as keynote 851 - ADA PLUMBING FIXTURE BY OWNER, in this case a kitchen sink.

3. A4.10 key note 851 states fixture "by owner," but note 345 (seemingly referring to the same fixture) says "per plumbing". Should we supply and install fixtures noted 851?

Response Per Architect:

Yes, you should supply the fixture, which is correctly notes "per Plumbing" in the plan note but mislabeled on the elevation.

4. A6.04 key note 612 – baffle system, unable to find spec section in the specifications. Please provide additional information.

### Response Per Architect:

*See attached cut sheet for frasch! BAFL acoustical ceiling baffle product: Exhibit A.* The Architect to select baffle colors from standard/available baffle options by manufacturer.

5. Specification section 11 31 00 - 2, 2.1 A. Appliances to be selected by the Architect. Could you provide us with a budget number for the appliances, or specify the make and model number of the appliances requested?


### Response Per Architect:

The design intent for the appliances is to select mid-range, readily available appliances in a stainless steel finish that will be durable and easily maintained and replaced by the Owner. Manufacturers in contention would be GE and Whirlpool. While specific models are not specified herein, GC shall provide bids based on this design intent with the understanding that the Architect is open to approved equals proposed by the GC that are of like cost and quality to these base brands.

### 6. A10.3 – Door 130B states that its ADA, but is only 2'8" wide and is not ADA compliant.

### Response Per Architect:

Door 13OB should be 2-10, not 2-8. The existing doorway is 2-8 +/- and must be adjusted to allow the ADA minimum clearance. See Detail 1 on Sheet D1 and highlighted snip below.



### **Contractor Question 7:**

1. Is there a spec for the clear coat paint material that will be applied to the existing plaster surfaces?


### Response Per Architect:



### Surface Preparation

Surfaces must be clean and sound, free of chalk, peeling paint, form oils, efflorescence, and mildew. Remove chalk, surface deposits, and loose or scaling paint by scraping, sanding, and preferably power washing. Repair all cracks and structural defects which could allow the intrusion of moisture. A common exterior paint failure on masonry construction is peeling and scaling, often caused by painting over heavy chalk deposits. The most practical and efficient way to remove this substance is by power washing. Multiple coats of paint that are in an advanced state of deterioration or prior applications of cement based coatings must be removed to a sound substrate. Sand blasting or using a mechanical grinder are effective means of preparation.

### **Primer/Finish Systems**

### **Unpainted and Weathered Masonry**

Loose, sandy masonry should be dry-brushed.

### **New Cured Masonry**

Prime with V027. Finish with necessary coats of V027 for a uniform finish. In hot weather, dampen porous masonry with water just before painting.

### **Uncoated Concrete and Masonry Floors**

When used as a dust controller, V027 must be applied to a clean, porous, uncoated substrate.

### Application

Care must be taken to achieve the specified wet and dry film thicknesses. Uniform, even coats must be obtained. Large horizontal surfaces should be spray applied; however, roller application can be performed.

### Application Equipment

Conventional or airless spray, brush, or roller.

**Spray, Airless:** Fluid Pressure —1,000 to 1,500 PSI;

Tip — .011 - .015 Orifice

### Thinning/Clean Up

Clean all equipment immediately after use with clean water. Spray equipment should be given a final rinse with mineral spirits to prevent rusting if compliant with local requirements.
